



Schuylkill BrewFest Homebrew Competition '11

Contest Rules

Who is Eligible to Enter?

The competition is open to any homebrewer from within the United States. Contestants will be considered as an individual entrant on the basis of person's name appearing on the registration form.

Homebrewers may not use homebrewing facilities other than their own. Beers brewed in commercially licensed facilities, whether for commercial research or production, or for any other purpose, are ineligible.

Entry Fees

There is a \$5 entry fee and you must purchase a ticket to Schuylkill BrewFest to participate. We will accept a maximum of 3 entries per festivalgoer.

Registration

Your entry should be registered via online PDF registration form and sent to the Schuylkill County Visitors Bureau, 300 South Centre Street, Pottsville, PA 17901. Participant's information must be submitted one week prior to the event. If you have any questions, please contact gina@schuylkill.org

Entry Drop Off

You MUST attend Schuylkill BrewFest on Saturday, October 15th to drop off your entry. Entries will be accepted from Noon until 3 pm the day of the event. The person who registered the beer needs to be the person who drops off the entry.

Entry Requirements

- Two bottles of the same beer must be entered for each entry.
- Only 3 ENTRIES will be allowed per person, with no more than 1 entry per subcategory
- Only beer may be entered. No mead, cider, or wine entries will be accepted.
- You MUST be 21 to enter.

Bottle Restrictions

- Entries must be 10 to 16 ounce glass or plastic bottles of ANY style and clean and free of any labels (inked, paper, or otherwise).
- Soft drink or other printed crowned caps are acceptable; however, they need to be blacked-out with a black marking pen to assure anonymity in all judging situations.

Late Entries and Disqualifications

- No entries will be returned whether received late or otherwise. All entries become property of the Schuylkill County Visitors Bureau.
- No late entries will be accepted. Entries will only be accepted at Schuylkill BrewFest on Saturday, October 15th from Noon until 3pm.
- Beers can be disqualified for bottle requirements infractions. These entries may still be judged but may be ineligible for awards or prizes. You will not be notified if your entry has been disqualified.

Entry Forms and Labels

- All Entries should be registered prior to drop off.
- Each entry must be submitted with a Bottle ID Form (attached to registration form). Use a rubber band to attach the form to the bottle. The use of tape or glue to attach forms is not acceptable.

Judging Information

- Blind tasting will be used. Judges will not be given the identity of the brewer or entrant.
- Judging will be as fair as possible to all entrants. Common rules will be used, and they will be applied.
- This competition will be run in a spirit of fairness.
- A judging panel will have a minimum of two judges and a maximum of four judges.

Judging Session

Length of time for judging will be dependent upon the amount of entries received and the number of judges that participate.

Prizes

Medal for 1st place overall.
